

RESOLUTION NO. 2022-13

A RESOLUTION OF THE HEBER PUBLIC UTILITY DISTRICT AMENDING POLICY MANUAL TO INCLUDE MODIFY POLICY NUMBER 3750 FACILITY USE POLICY

WHEREAS, the Heber Public Utility District desires to provide guidelines for the safe and efficient use of District owns parks and recreation facilities; and

WHEREAS, the District adopted Ordinance 220 on April 10, 1980 that prohibited beverages in the form of glass, the deposit of litter, alcoholic beverages, and the acts of vandalism in all parks and facilities of the District; and

WHEREAS, the District has determined that Ordinance Number 220 is essentially obsolete, void and unenforceable; and

WHEREAS, the Heber Public Utility District adopted Policy Number 3750 Titled Facility Use Policy on May 1, 2016 and has adopted an amendment to this policy on July 15, 2021; and

WHEREAS, Policy Number 3750 Titled Facility Use Policy addresses all of the prohibiting sections of Ordinance 220 with the exception of Section 2 titled "Beverages in Glass Containers"; and

WHEREAS, the Heber Public Utility District desires to modify Policy Number 3750 to include prohibiting the use of glass containers in all parks and recreation facilities; and


WHEREAS, the District desires to adopt a policy that ensures compliance with laws, and protect the safety of people who use our parks and facilities; and

NOW, THEREFORE, BE IT RESOLVED by the Board of Directors of Heber Public Utility District:






