PROGRESS REPORT FOR HPUD CHILDREN'S PARK

HPUD CHILDREN'S PARK COMMITTEE MEETING OUTCOME

- 1. A project plan review meeting was conducted on January 31, 2022 with HPUD Park Committee members and operators via Zoom. The following items were reviewed at the meeting:
 - a. Motion sensor solar lights were added at the picnic shade at the southeast corner of the park and also at the southwest corner of the new restroom/mechanical room building.
 - b. A toddler safe pedestrian swing gate was added at the west farthest entrance from Crane Court to protect the children from running out to the street.
 - c. Bicycle rack and pet bag dispenser sign were added. Scooter stands were also added to the plans.
 - d. Need for the Aquatic Facility Operator (AFO) Certification Class was reviewed with the HPUD operator.
- 2. The necessity of increasing the height of the fencing along the south property line abutting the alley was reviewed for the purpose of increasing security for the park. The committee mutually agreed that the existing fencing along the south side of the property remain in place. The project requires the existing fencing be adjusted to relocate the rolled gate opening location to accommodate the new site layout. If it is costly to adjust the existing fencing, the fencing may be replaced with a temporary chain link fence (instead of replacing with tubular fence) as the fencing will be removed/replaced anyway when the alley is improved as a trail path in the near future.
- 3. The committee requested that the façade improvements to the existing picnic shade structures be added to the scope of work.

DESIGN PHASE - COMPLETE

- 1. Project Plans and Specifications were completed.
- 2. Engineer's Opinion of Probable Quantity Estimate was prepared.
- 3. Engineer's Opinion of Probable Cost Estimate will be completed by February 18th, 2022.
- 4. Façade improvement design of the existing picnic shade structures was prepared per the Park Committee's request. Schematic design plans are attached.

PERMIT PROCESS

- 1. Permit Applications along with the Project Plans and supporting documentation were submitted to:
 - County of Imperial Planning and Development Services;
 - County of Imperial Public Health Department;
 - County of Imperial Public Works Department; and
 - County of Imperial Fire Department (Preliminary comments were received and addressed on the plans).
- 2. Customer Project Development Services Application was submitted to Imperial Irrigation District Energy Division. Preliminary review comments were received, and the electrical plans were updated to reflect the IID's comments.

BIDDING PHASE


- 1. Legal Advertisement of the project was published on the Imperial Valley Press newspaper on Friday, February 11, 2022. The advertisement will be placed again on Friday, February 18, 2022.
- 2. Pre-bid Conference will be conducted on Friday, February 25, 2022 at the Children's Park.

ALLEY RIGHT OF WAY VACATION


- 1. A meeting was conducted with the County of Imperial representatives to review the status of the ROW vacation of the alley south of the Children's Park on Thursday, February 10, 2022.
- 2. It was mutually agreed at the meeting that proceeding with a lease agreement with the County of Imperial for the triangular piece (versus going for the entire alley vacation process) is the quickest way to secure the title of the alley to move forward with the park renovation project.
- 3. Response/approval from the County of Imperial Public Works Department and Legal Counsel is pending.






FOUNDATION WITH POST LOCATIONS




