- **SUBJECT:** Adopt Resolution 2021-10 Approving the Submittal of a Grant Application to the USDA Rural Development Under the Community Facilities Loan and Grant Program for FY 2021-22.
- **ISSUE:** Shall the Board Adopt Resolution 2021-10 to approve the submittal of a grant application to the USDA Rural Development Community Facilities Loan and Grant Program for improvements to the Recreation Center to purchase furniture and equipment?

## General Manager's Recommendation:

Adopt Resolution 2021-10 to approve the submittal of a grant application for USDA Rural Development Community Facilities Loan and Grant Program for the purchase of furniture and equipment at the Heber Recreation Center.

## FISCAL IMPACT:

The USDA Rural Development Community Facilities Loan and Grant Program requires a 25% matching funds, which is included in the HPUD 2021-22 equipment outlay budget. The total of the HPUD commitment for matching funds for the three (3) grants awarded by USDA is \$41,597.00. This amount exceeds the budget by \$1,597.00. Staff does not recommend making a budget adjustment at this time as the \$1,597.00 will not result in an exceedance of the overall Parks and Recreation budget.

Total Furniture and Equipment Cost - \$44,966 USDA Rural Development Community Facilities Grant Award - \$33,700 HPUD's Contribution Matching Funds - \$11,266

## BACKGROUND:

Heber Public Utility District Board of Directors voted in favor of submitting a grant application for three improvement projects at the Heber Recreation Center. The USDA Rural Development Community Facilities Program requires a separate application for each project request.

During the budget process the projects were identified, estimated, and the matching component was calculated and included in the budget. The FY 2021-22 Equipment Outlay budget for the Parks and Recreation Department included \$40,000 for matching funds. The total of the HPUD commitment for matching funds for the three (3) grants awarded by USDA is \$41,597.00. This amount exceeds the budget by \$1,597.00. Staff does not recommend making a budget adjustment at this time as the \$1,597.00 will not result in an exceedance of the overall Parks and Recreation budget.

## **RECOMMENDATION:**

Staff recommends adopting Resolution 2021-10 approving the submittal of an application to the USDA Rural Development Community Facilities Program for the purchase of furniture and equipment for the Heber Recreation Center and obligate matching funds in the amount of \$11,266.

## ALTERNATIVES:

- 1. Do not adopt Resolution 2021-10, which would postpone the project, which has been approved and awarded by USDA.
- 2. Provide alternate direction for the submittal of the application and the facility improvements.
