Subject: April 2022 Monthly Report

On the billing cycle ending on the 23rd of April 24,843,000 gallons of water were used by our consumers, an average of 801,000 gallons was used per day.

On April 21, 2022, collected Trihalomethanes (TTHM's) samples and were sent to Clinical Lab of San Bernardino for analysis. The results came in on May 2, 2022 and were below the running annual average (RAA) MCL the maximum contaminant levels (MCL) for TTHM's. The running annual average (RAA) MCL for TTHM's is 80 parts per billion (ppb) and we attained 65 ppb for the Mc Cabe site and 46 ppb for the Little Field site. Heber Public Utility District continues to be in compliance with the State and Federal Water Regulations.

On April 18, 2022, Operator noticed a chemical spill on the static mixer station. Most of the chemical was confined within the chemical concrete pad containment. Some chemical went outside the HPUD water plant facility and was barricaded to prevent exposure to people. EFR Environmental Services was immediately contracted to clean up and properly dispose of chemical Spill.

On April 22, 2022 received an alarm of backwash pump failure. The backwash pump is used to clean the water filters. Upon inspection the pump had ceased and was placed offline. Currently, we have a second pump which is functional and have ordered the parts to have it refurbish. The pump should be installed and operational by the end of May 2022.
