1. The Due Date and Time of the Proposal has changed. The New Date and Time required for the submittal of the proposal is Friday September 13, 2024 at 10:00 AM.
2. The Bidder shall comply with Worker's Compensation Insurance requirements. A Contractor's Certification Regarding Worker's Compensation Insurance, as attached in the Proposal Form, is to be submitted with the Bid.
3. The Bidder shall comply with Non-Collusion requirements. A Contractor's Non-Collusion Affidavit, as attached in the Proposal Form, is to be submitted with the Bid.
4. The Proposal Forms have been revised. The revised Proposal Forms are attached to this addendum.
5. The new Valve Bluetooth Controllers shall be RainBird TBOS-BTLT1, Hunter NODE-BT-100-LS, or approved equal that is equipped with 1 Stations for each of the 42 valves.
6. All new Valves shall be installed with a DC Latching Solenoid that is compatible with the Valve Bluetooth Controller.
7. The Contractor shall set up a controller software application to allow for control of the valves remotely, such as a mobile application. Training for the use of the controller application shall be provided to HPUD Staff.
8. Replacement of existing Valves and Sprinkler Heads shall be replaced with in-kind sizes.
9. The Project Scope of Work shall be completed within 45 calendar days from that of the Date of Agreement.
