Subject: September 2024 Monthly Report

On the billing cycles ending on the 20TH of September 36,091,000 gallons of water were used by our consumers, an average of 1,164,000 gallons was used per day.

On September 19, 2024 collected third quarter TTHM's samples and were sent to Clinical Lab of San Bernardino for analysis. The results came in on September 27, 2024 and were below the maximum contaminant level (MCL) for the both sites. The running annual average (RAA) MCL for TTHM's is 80 parts per billion (ppb) and for the month of September of 2024 we attained a RAA of 62 ppb for the Mc Cabe Cove site and 50 ppb for the Little Field site. Heber Public Utility District is in compliance with State and Federal water regulations.
