Enclosed, you will find the Monthly Monitoring Report for the Heber Wastewater Treatment Plant for the month of June 2024.

- A. Major violations: (ONE) We collected a composite sample on May 15, 2024 to test for Chronic Green Algae, and failed the test with a 93.2% effect. We re-tested for the Chronic Green Algae on June 12, 2024 and we are waiting for the final test results. We received the results and failed again for the chronic green algae at 94.7% effect. Our laboratory analyst told us that there were ciliates in our effluent and, for that reason we did not pass our toxicity test. HPUD will find ways to correct the problem.
