Subject: October 2024 Monthly Report

On the billing cycles ending on the 21st of October 30,006,000 gallons of water were used by our consumers, an average of 968,000 gallons was used per day.

On October 17, 2024 collected fourth quarter TTHM's samples and were sent to Clinical Lab of San Bernardino for analysis. The results came in on October 29, 2024 and were below the maximum contaminant level (MCL) for the both sites. The running annual average (RAA) MCL for TTHM's is 80 parts per billion (ppb) and for the month of October 2024 we attained a RAA of 62 ppb for the Mc Cabe Cove site and 50 ppb for the Little Field site. Heber Public Utility District is in compliance with State and Federal water regulations.


