Subject: January 2025 Monthly Report

On the billing cycle ending on the 20th of January 18,836,000 million gallons of water were used by our consumers, an average of 607,000 thousand gallons was used per day.

On January 29, 2025 collected the 1st quarter Trihalomethanes (TTHM's) and Haloacetic Acids (Haa5) samples and were sent to Clinical Lab of San Bernardino for analysis. The results came in on February 7, 2025 and were below the maximum contaminant levels (MCL) for TTHM's. The running annual average (RAA) MCL for TTHM's is 80 parts per billion (ppb) and we attained 54 ppb for the Mc Cabe site and 42 ppb for the Little Field site. Heber Public Utility District continues to be in compliance with the State and Federal Water Regulations.
