A RESOLUTION OF THE BOARD OF DIRECTORS OF HEBER PUBLIC UTILITY DISTRICT, RATIFYING A LOCAL EMERGENCY AND THE PROCLAMATION OF STATE OF EMERGENCY AS A RESULT OF TROPICAL STORM MARIO

WHEREAS, Tropical Storm Mario, has weakened but continues to produce remnant moisture resulting in heavy, rainfall across parts of southern California;

WHEREAS, the rainfall has caused flash flooding, road closures, debris flows, and property damage, in the desert region to include Heber;

WHEREAS, dangerous conditions exist, including blocked or washed out roads, risk to life and safety, particularly in flood-prone and burn-scarred areas;

WHEREAS, C.A. Government Code §8630 empowers the Board of Directors to proclaim the existence or threatened existence of a local emergency when said District is affected or likely to be affected by a public calamity, and

NOW, THEREFORE, BE IT PROCLAIMED that a local emergency now exists throughout the Heber Public Utility District Service Area, and;

BE IT FURTHER PROCLAIMED that during the existence of said local emergency the powers, functions, and duties of the emergency organization of this District shall be those prescribed by state law, by ordinances, and resolutions of this District.

BE IT FURTHER PROCLAIMED hat a copy of this Resolution be forwarded to the State Director of the Governor's Office of Emergency Services with the request that the Governor proclaim that a State of Emergency exists in the Heber Public Utility District Service Area and afford the District the benefit of recovering the costs and afford disaster assistance including assistance afforded under the California Disaster Assistance Act (CDAA) a result of the emergency.

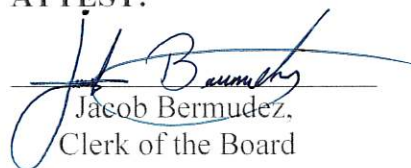

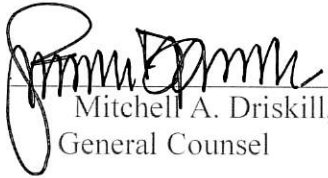

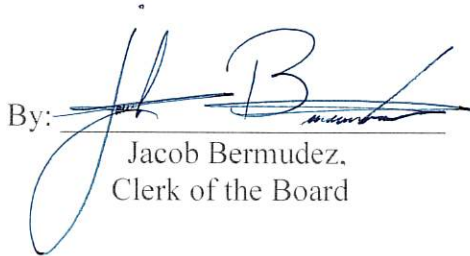
